Official Rules for the Clips Nation Game Prediction Contest

No Purchase Necessary. A Purchase Will Not Increase Your Chances of Winning.

- 1. **Eligibility**: The Clips Nation Game Prediction Contest (the "<u>Contest</u>") is open only to legal residents of the United States and Canada (excluding Quebec) who, at the time of entry, are at least eighteen (18) years of age and are registered members of <u>www.clipsnation.com</u> (the "<u>Contest Site</u>"). Employees, independent contractors, interns, officers, directors, and agents of Sponsor, other companies associated with the Contest, the judges, as well as the immediate family members (spouse, parents, siblings, and children, and their respective spouses) and household members of any of the foregoing are not eligible to enter.
- 2. **Sponsor:** The Contest is sponsored by Vox Media, Inc., 1201 Connecticut Avenue NW, Washington, DC, 20036 ("Sponsor").
- 3. **Agreement to Official Rules:** By entering the Contest, you indicate your full and unconditional agreement to, and acceptance of, (a) these Official Rules and (b) Sponsor's decisions, which are final and binding. Winning a prize is contingent upon fulfilling all requirements set forth herein.
- 4. **Entry Period:** The Contest begins at 12:00 PM (ET) on November 5, 2013, when the Sponsor announces on the Contest Site that the entry period for the Contest has started and the Sponsor will be accepting game winner predictions in connection with LA Clippers basketball game against the Houston Rockets to be held on November 9, 2013 (the "Rockets Game") and will continue until 7:00 PM (ET) on November 9, 2013 (the "Entry Period"). Prior to the start of the Entry Period, the Sponsor will post a written announcement on the Contest Site (the "Contest Post") and ask members to use the provided GoogleForm to predict the game winner for the designated Game. Entries submitted before the Entry Period has started, of after the Entry Period has ended, will not be eligible.
- 5. **How to Enter:** To enter the Contest, you must (a) be a registered user of the Contest Site, and (b) submit predictions in response to the Contest Post. There is a limit of one (1) entry per person/user name for the Contest Site. Entries will not be acknowledged.
 - a. <u>Becoming a Registered User</u>. Visit the Contest Site and if you are not already a registered user of the Contest Site, click "Sign Up" and register as a member of the Contest Site. Once registered, login to the Contest Site with your account username and password.
 - b. <u>Submitting an Entry</u>. Once the Contest Post is live on the Contest Site, use the designated GoogleForm to submit your predictions (an "<u>Entry</u>"). An Entry will be deemed ineligible if it does not contain, a prediction for each category set forth in the Google Form.

The odds of being selected as the winner depend on the number of entries received and the performance of each entrant.

- 6. **Scoring.** For the Game, entrants will earn points in the following manner:
 - a. Winner. 100 (100) points for correctly guessing the winner of the Clippers vs. Rockets Game on November 9, 2013 (the "Rockets Game").
 - b. Clippers leaders. Ten (10) points each for correctly guessing the Clippers' leaders in the Rockets Game for points, rebounds and assists (in the event multiple players are leading a category, predictions for each leading player will be awarded ten (10) points).
 - c. Rockets leaders. Ten (10) points each for correctly guessing the Rockets' leaders in the Rockets Game for points, rebounds and assists (in the event multiple players are leading a category, predictions for each leading player will be awarded ten (10) points).
 - d. *Margin of victory*. Five (5) points for correctly guessing the final margin of victory in the Rockets Game or for the guess or guesses that are closest to the actual margin of victory.
 - e. *Clippers total points*. One (1) point for correctly guessing the Clippers point total in the Rockets Game or for the guess or guesses that are closest to the actual point total.

The Sponsor will calculate and aggregate scores for all entrants. The entrant that has accumulated the most points at the conclusion of the Rockets Game shall be selected by the Sponsor as the winner. In the event of a tie between one or more entrants, Sponsor will select one (1) winner in a random drawing of the tied entrants

- 7. **Notification and Requirements of Potential Winners**: Sponsor will attempt to notify potential winners within four (4) hours of the conclusion of the Rockets Game. If a potential winner does not respond within twenty four (24) hours after the notice is sent, the Sponsor will select an alternate potential winner in his/her place according to the Judging Criteria. Only one (1) alternate potential winner will be contacted. Except where prohibited, a potential winner may be required to complete and return an affidavit of eligibility and liability/publicity release. If a potential winner is a minor, his/her parent or legal guardian will be required to sign the documents on his/her behalf.
- 8. **Prize(s):** One (1) prize will be awarded. *Description of Prize:* Two (2) tickets to the Hyde Lounge at the Staples Center for the Clippers game versus the Minnesota Timberwolves on November 11, 2013, at 7:30 PM. Transportation, parking, and food and beverages are not included. *ARV of Prize:* US \$230. A winner is responsible for paying any applicable income taxes and any and all other costs and expenses not listed above. Any prize details not specified above will be determined by Sponsor in its sole discretion. A prize may not be transferred and must be accepted as awarded. Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Contest or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Any attempt by any person to undermine the legitimate operation of the Contest may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Failure by Sponsor to enforce any term of these Official Rules shall not constitute a waiver of that provision. Proof of sending any communication to Sponsor by mail shall not be deemed proof of receipt of that communication by Sponsor. In the event of a dispute as to any online entry, the authorized account holder of the e-mail address used to enter will be deemed to be the participant. The "authorized account holder" is the natural person who is assigned to an email address by an Internet access provider, online service provider, or other organization responsible for assigning email addresses for the domain associated with the submitted e-mail address. The Contest is subject to federal, state, and local laws and regulations and is void where prohibited.
- 10. Release and Limitations of Liability: By participating in the Contest, you agree to release and hold harmless Sponsor, its parent, subsidiaries, affiliates, and each of their respective officers, directors, employees, and agents (the "Released Parties") from and against any claim or cause of action arising out of participation in the Contest or receipt or use of any prize, including, but not limited to: (a) unauthorized human intervention in the Contest; (b) technical errors related to computers, servers, providers, or telephone, or network lines; (c) printing errors; (d) lost, late, postage-due, misdirected, or undeliverable mail; (e) errors in the administration of the Contest or the processing of entries; or (f) injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Contest or receipt or use of any prize. You further agree that in any cause of action, the Released Parties' liability will be limited to the cost of entering and participating in the Contest, and in no event shall the Released Parties be liable for attorney's fees. - 12. **Disputes:** Except where prohibited, you agree that any and all disputes, claims and causes of action arising out of, or connected with, the Contest or any prize awarded shall

be resolved individually, without resort to any form of class action, and exclusively by the appropriate court located in Washington, DC. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, your rights and obligations, or the rights and obligations of Sponsor in connection with the Contest, shall be governed by, and construed in accordance with, the laws of Washington, DC, without giving effect to any choice of law or conflict of law rules (whether of Washington, DC or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than Washington, DC.

Unless otherwise stated to the contrary in these Official Rules, this Contest is not sponsored, endorsed or administered by, or associated with, any Third Party Platform.
